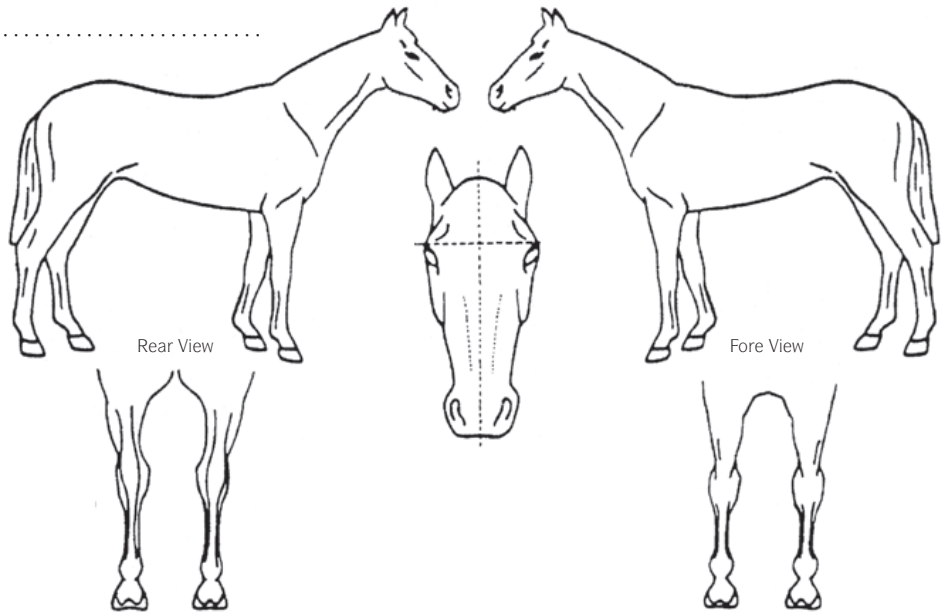

OAKS SPORT HORSES CHILLED SEMEN CONTRACT

I / We agree to the following conditions:

1. This signed contract is a tax invoice.
2. Semen will be sent after payment of \$2500 inc GST which is the nominated Service Fee for the Oaks Sport Horses Stallion 'Casting'. This includes a non-refundable using/booking fee of \$500 inc GST.

3. The mare information sheet must also be received by Oaks Sport Horses before semen will be collected and sent.
4. All collection costs, transport costs and vet costs associated with the collection, transport and insemination of the mare are the mare owner's responsibility. No responsibility can be accepted for the loss during transport of chilled semen by Oaks Sport Horses or our vets, Agnes Banks Equine Clinic.
5. One Service Certificate will be issued per service fee paid. In the case of Embryo Transfer, if two mares are bred with one insemination dose and both are pregnant, or if two embryos are positively transferred from one breeding, a second service fee is payable for the second pregnancy.
6. The service fee is non-refundable and non-transferable (that is, semen cannot be given or sold to a 3rd party).
7. A Live Foal Guarantee entitles the mare owner to a return breeding for the same mare to the same stallion in the subsequent breeding season. This applies only in the case that the mare should a) abort the foetus or b) the foal dies within 24hrs of birth. A veterinary certificate must be supplied in all cases. The LFG is limited to one (additional) service/collection.
8. Should the stallion not be available for cover during that next season via fresh/chilled semen, frozen semen will be available. If this is not suitable then a refund of \$1,000 will be given. The season will run from 1st October until 31st March.
9. A service certificate will be issued after a vet issues a 45-day pregnancy test document which has been received by Oaks Sport Horses. Please ensure you send a copy of your 45-day pregnancy test, as this will be needed should your mare fail to produce a viable foal.
10. If the mare fails to produce a viable foal, then a vet certificate must be sent to Oaks Sport Horses. When claiming a free return for the no birth of a viable foal, it must be dated and received within 14 months of the original insemination date that resulted in pregnancy.

Mare owners must complete the mare information including diagram of markings and brands.
