- 1. This signed contract is a tax invoice.
- 2. Semen will be sent after payment of \$2500 inc GST which is the nominated Service Fee for the Oaks Sport Horses Stallion 'Casting'.

- 3. The mare information sheet and a signed Veterinarian's Agreement must also be received by Oaks Sport Horses before semen will be sent.
- 4. All transport costs and insemination of the mare are the mare owner's responsibility. No responsibility can be accepted for the loss during transport of frozen semen by Oaks Sport Horses or our vets, Agnes Banks Equine Clinic.
- 5. The semen is provided for the purpose of achieving ONE successful pregnancy by insemination of the mare specified.
- 6. If you achieve one successful pregnancy (at 18 days) and wish to use the remaining semen to attempt to achieve another pregnancy, you must first enter into a new contract with Oaks Sport Horses and pay for another service fee.
- 7. If you achieve a successful pregnancy (at 18 days) and do not wish to use the remaining semen to achieve a second pregnancy, the semen must be returned to Oaks Sport Horses.
- 8. One Service Certificate will be issued per service fee paid. In the case of Embryo Transfer, if two mares are bred with one insemination dose and both are pregnant, or if two embryos are positively transferred from one breeding, a second service fee is payable for the second pregnancy.
- 9. The service fee is non-refundable and non-transferable (that is, semen cannot be given or sold to a 3rd party).
- 10. 3 doses will be sent to the breeder. If the mare does not go in foal after the second insemination the owner may nominate another mare. The mare owner is entitled to a return breeding for the same mare to the same stallion in the subsequent breeding season if the mare should slip after 18 days and before July 1. A veterinary certificate must be supplied. There is no live foal guarantee.
- 11. A service certificate will be issued on OSH receipt of a vet-issued a 45-day positive pregnancy test document. Please ensure you send a copy of your 45-day pregnancy test, as this will be needed should your mare slip before July 1.
- 12. If you have not achieved one pregnancy (at 18 days) after 3 inseminations, another 3 inseminations may be purchased at half price.
- 13. If your pregnant mare dies before foaling you may purchase another 3 inseminations at half price to achieve one pregnancy
- 14. If the mare fails to go in foal for any reason, the mare owner will have no recourse to Oaks Sport Horses
